**CULTURAL AND SCIENTIFIC INTERNATIONAL FRAMEWORK AGREEMENT  
BETWEEN THE UNIVERSITY OF SALERNO (ITALY) AND ISFAHAN UNIVERSITY OF  
TECHNOLOGY**

The **Isfahan University of Technology** represented by its President Prof. S. M. Modarres Hashemi, and the **University of Salerno** (Italy), represented by its Rector Prof. Aurelio Tommasetti (hereinafter "the Universities"), considering that promoting international cooperation in studies and scientific research is one of their common goals, enter into the following Framework Agreement.

**Art. 1 – PURPOSE**

The Framework Agreement is a legal instrument expressing a "general interest" in promoting and developing cooperation between the Institutions. It will be carried out in all fields and subjects of common interest by means of specific agreements (supplementary agreements) containing the aim of the scientific and/or cultural cooperation, the manner of execution, the responsibilities and the expected results. Each institution will designate a Project Coordinator to be responsible for the reports at the Academic Bodies.

**Art. 2 – COOPERATION ACTIVITIES**

Cooperation between the Institutions includes joint and coordinated teaching and research programs. The activities can be developed through:

- exchange of teachers, researchers, administrative staff and students;
- realization of common research projects of shared interest;
- exchange of information, documents and scholarly publications of shared interest;
- organization of events such as conferences, seminars, meetings, etc.;
- reciprocal use of the existing facilities of both the Institutions;
- realization of joint educational programs.

**Art. 3 – RESPONSIBILITIES AND FINANCING**

Supplementary agreements will follow to define sectors of interest of the Structures involved in the Programme, to appoint the academic responsible, one for each sector, to specify the ways of exchanging scholars and of carrying out research and educational programs, as well as any related expenses. Both Institutions will make every effort to seek sources for financing the activities, according to the rules of the respective countries. The Structures involved shall support possible costs, within the limits of their own available funds which shall be determined by common consent.
